These Booking Conditions incorporate the conditions of carriage of any carrier providing transport of any kind including by land, sea and air and embody the provisions of the law of the country of the carrier concerned and may be subject to International Convention either or both of which may limit or evolude the liability of any Carrier. The following definitions are to be applied throughout these Booking Conditions:

'Booking Party' means any and all Guests named and/or travelling under your booking and Contract including all Minors and persons under your custody.

In the event that *Disney Quise Line* is responsible for any death, injury or liness caused by the negligent acts and/or omissions of its suppliers of services which form part of the Cruise Package then *Disney Quise Line* initis its liability, where applicable by the International Air Conventions, including the Wassaw Convention 1929 (as amended by The Hague Protocol 1956 or the Montreal Protocol 1999 or otherwise). Flights between the LlK and any member state of the European Union are currently governed by EC Regulations 889/2002 which gives legal effect to the Montreal Convention 1999.
